

Key Business Performance Summary at 30 June 2021

As at 30 June 2021, the Redress Board has received **1,641** applications. Unfortunately, **174** of these applications did not comply with the Rule 4 statutory requirements and remain **incomplete.** It is important to note that the Board has elected to issue the Rule 7 Notice to verify the applicant's attendance at an institution this process regardless of whether or not an application is complete in order to reduce any further delay. However, these applications cannot be progressed to a panel until the outstanding information is provided by applicants and so fall outside the control of the Board and are discounted for the purposes of this summary.



Payments Summary

As at **30 June 2021**, Redress Board panels have made award determinations totalling £20,037,000 including Section 14 awards.

Following section 13 actuarial adjustments, £19,329,125 is payable to applicants.

£16,656,039 has been paid directly into the applicant or applicant's solicitor's account on receipt of an Acceptance of Award from the applicant.



Appeal Summary

As at **30 June 2021**, the Redress Board has received **113** Notices of Appeal. This equates to approximately 14% of final determinations made by panels.

71 appeals have been considered by a single judicial member with **25** being upheld and **46** dismissed confirming the panel decision.

Applications Received

The Redress Board have received **1,641** applications for compensation.


- 239 applications (15%) are from applicants who gave evidence to the Hart inquiry;

Panel Sessions


Redress Board panels have met on **290** occasions considering **1,091** applications. It should be noted that the same application may have been before a panel more than once during this period.

Further to this a single judicial member has sat on **63** days dealing with the work associated with appeals.


