

Key Business Performance Summary at 30 September 2021

- 204 panel meetings considering 835 applications in the first two quarters of 21/22 compared to 195 panel meetings considering 713 applications in all of 20/21.
- 726 applications full determined/withdrawn in the first two quarters of 21/22 compared to 527 in all of 20/21.
- £13.6m paid to applicants in the first two quarters of 21/22 compared to £10.5m in all of 20/21.
- **76%** of all complete applications have been considered by a panel.

As at 30 September 2021, the Redress Board has received **2,006** applications. Unfortunately, **208** of these applications did not comply with the Rule 4 statutory requirements and remain **incomplete.** It is important to note that the Board has elected to issue the Rule 7 Notice to verify the applicant's attendance at an institution this process regardless of whether or not an application is complete in order to reduce any further delay. However, these applications cannot be progressed to a panel until the outstanding information is provided by applicants and so fall outside the control of the Board and are discounted for the purposes of this summary.


*If the Redress Board receives a Rule 7 Notice response that does not confirm the applicant's attendance it will undertake additional investigations on behalf of the applicant, to source alternative information from other statutory and voluntary bodies and record archives to confirm the statutory information requirements of the Rule 7 Notice.

Payments Summary

As at **30 September 2021**, Redress Board panels have made award determinations totalling **£28,113,500** including Section 14 awards.

Following section 13 actuarial adjustments, £27,348,461 is payable to applicants.

£24,109,678 has been paid directly into the applicant or applicant's solicitor's account on receipt of an Acceptance of Award from the applicant.



Appeal Summary

As at **30 September 2021**, the Redress Board has received **165** Notices of Appeal.

115 appeals have been considered by a single judicial member with **42** being upheld and **73** dismissed confirming the panel decision.

The Redress Board has received **2,006** applications for compensation.


- 247 applications (12%) are from applicants who gave evidence to the Hart inquiry;

Panel Sessions


Redress Board panels have met on **399** occasions considering **1,548** applications. It should be noted that the same application may have been before a panel more than once during this period.
